

Brief Resume of the Rules of the Southgate Club Limited

Rule.1. Club Opening Hours

Displayed within the Club and Dependant on Functions being held.

Rule.2. Permitted hours of sale of excisable liquor

Displayed within the Club and Dependant on Functions being held.

Rule.3. Damage Caused within the Club

All careless damage to the property of the Club shall be made good to the satisfaction of the Committee by the Member or Member(s) causing same.

Rule.4. Serving of Refreshments

The Bar manager /Deputy Bar manager or any staff shall have full discretion as to serving members with refreshments.

Rule.5. Credit

All refreshments shall be paid for at the time of service according to the current Bar Tariff. Under No Circumstances shall credit be given.

Rule.6. Complaints against Staff

The conduct of the Bar manager/Deputy Bar Manger or any other member of staff shall in no circumstances be a matter for personal reprimand by any member. Any complaint shall be made in writing and delivered to the Secretary, who will bring the same before the Committee.

Rule.7. Removal of Club Property

No member shall remove any Newspapers / Magazines or other property from the Club or cut or deface the same or erase or deface or otherwise interfere with any Notice officially displayed on the Club's premises.

No Bill , Notice ,Placard or Newspaper shall be posted or distributed in or about the premises without the permission of the Club Secretary.

Rule.8. Illegal Gaming

No illegal game of cards or other illegal games shall be played in the club.

Rule.9. Billiards and Snooker

Charges for all games shall be determined by the Committee from time to time.

Rule.10. Committees

Committees such as House, Finance and Entertainment shall be formed at the discretion of the Board of Directors for the purpose of the internal management and well-being of the Club. Each such Committee shall consist of such number of members as the Board of Directors determines.

Rule.11. Dress

.1. On all occasions dress must be neat and tidy.

.2. No Jeans, Training Shoes are allowed to be worn on Club nights in 'Obies Bar'.

.3. Any exemption to .2. above will be considered dependant on the occasion i.e. Fancy Dress or Disco evenings.

.4. Members have the right to challenge any person in the club considered to be offending against the above standards. (with the exception of Rule.6. above).

Rule.12. Smoking

The smoking of Cigarettes and or Cigars /Pipes is not permitted anywhere within the Club Building.

Rule.13. Subscriptions

The Annual subscription shall be such sum as decided by the Board of Directors from time to time.

All subscriptions shall become due and payable in advance of the 1st January each year. Members who have not paid the current subscription by January 31st shall not be entitled to enter the club and will have their membership revoked. (unless an extension of time has been applied for and approved by the Committee). Any member ceasing to belong to the club by resignation or otherwise shall not be entitled to have any part of their subscription refunded.

Rule.14. Visitors / Guests

Members may personally introduce friends as visitors at reasonable intervals, but no member may introduce any person whose name has been rejected on any previous application for Membership or who has been expelled from the Club. Members shall be responsible for the conduct of visitors introduced by them and for their strict observation of Club rules. No visitor shall remain on the premises after the member by whom they have been introduced has left the premises. Not more than 4 visitors may be introduced at any one time. Visitors to the area may be elected as temporary members by an officer of the club for a period not exceeding 28 days on payment of a subscription to be decided by the Committee.

Visitors must pay a nominal fee for entrance and be signed in by the member. (more details are displayed in Milners' bar).

Members are encouraged to introduce visitors to become members of the club should they attend the club on more than 3 occasions.

Rule.15. Powers of Expulsion

No Drunkenness, bad language or disorderly conduct will be permitted in the club. In the event of any member wilfully infringing the club rules or conducting themselves in a manner derogatory or injurious to the character or interests of the club, the Committee may suspend the privileges of membership for any period or call upon the member to resign his membership. If such a member does not resign within 10 days of the resolution being communicated, the Committee may expel such member.

Rule.16. Membership of The Southgate Club Limited

Sole Membership of the Southgate Club Limited confers No Voting rights in respect of the Southgate Members Club Limited.

Rule.17. New Applicants for Membership

All New Applicants for Membership shall have their names and addresses displayed for a period of 10 days within the Club before any Membership is granted.

Rule.18. Interpretation of the Rules

The Committee shall be the sole authority for the interpretation of the rules made and the decision of the Committee upon any question of interpretation or upon any matter affecting the club and not provided for by these rules shall be final and binding on the members.
